



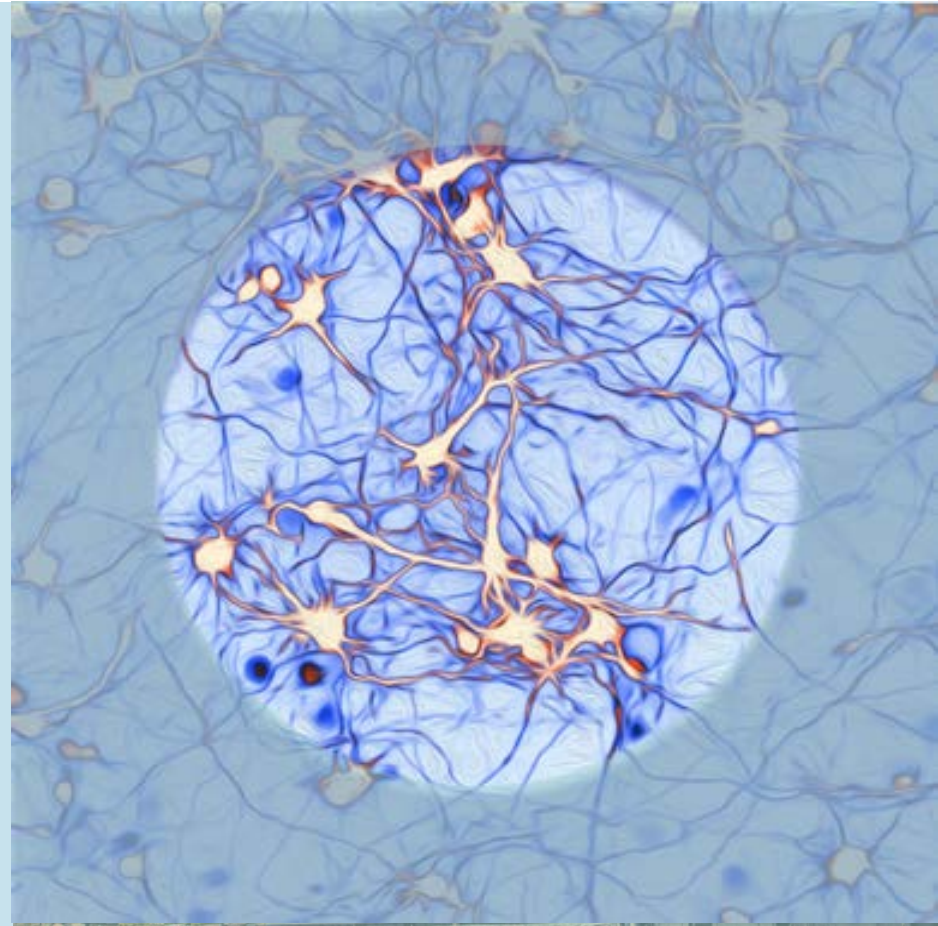

The role of NHMRC: Strategic Direction

invest in high quality health and medical research and build research capability, supporting the best research and researchers

support the translation of health and medical research into clinical practice, policy and health systems and the effective commercialisation of research discoveries

maintain a strong integrity framework for research and guideline development, underpinning rigorous research and relevant and accurate guidelines and promoting community trust

A new Code was released in 2018

- Code is principles-based
- 8 principles, 29 responsibilities
 - Support high-quality research
 - Enhance credibility of research
 - Promote community trust
- All disciplines at all research institutions
- Co-authored with ARC/UA

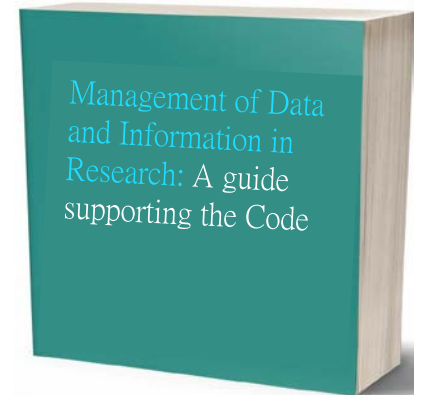
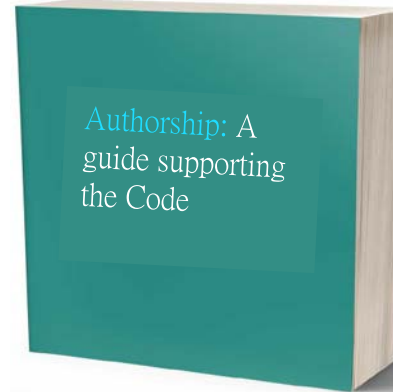

How is the Code disseminated?

- NHMRC and ARC websites
- Webinars
- Gave talks on invitation
- Targeted and public consultation



How is the Code disseminated?

Referred to in key NHMRC and ARC documents



By working closely with institutions, NHMRC supports Code implementation by:

- providing general advice
- keeping institutions accountable for length of investigations and making improvements
- ensuring guides are relevant and practical



Determinants of success



NHMRC has a range of ways of *generally* finding out how Code implementation success, such as:

- Data provided in Institutional Annual Compliance Report
- Notifications about investigations/integrity matters
- Reviews by ARIC
- Start to see more consistency
- Inquiries from institutions to clarify aspects of the Code and Guides
- Feedback from institutions about how they are working with the Code and the usefulness of the Guides

Determinants of success

But interpretation of data is difficult, for example:

Does more complaints about research integrity mean implementation of Code is improving or worsening?

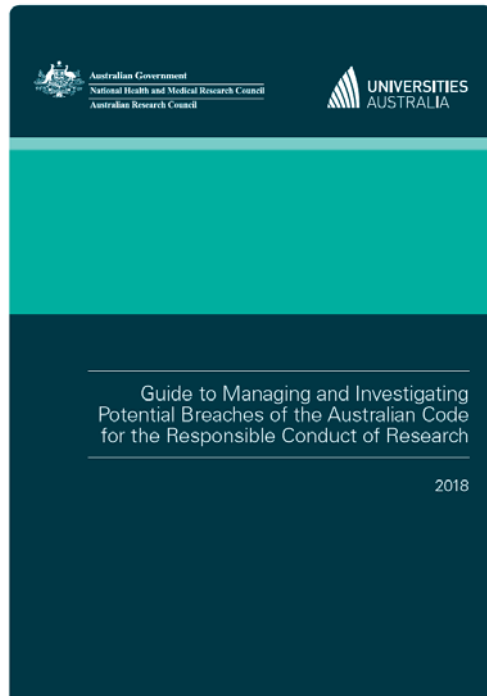
What does an increase in requests for ARIC review mean?

Is there consistency between institutions in the conduct of investigations?

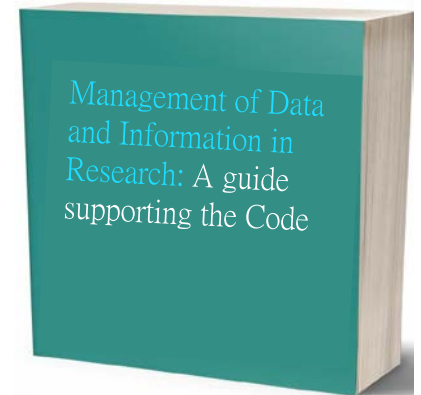
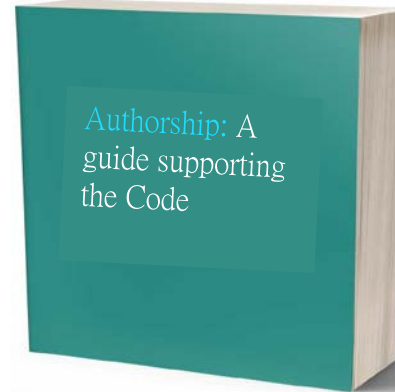
How do you quantitate implementation of principles such as honesty?
